

Information CSIO Zuidwolde 2026



Please read this information letter carefully!

❖ **Arrival times**

Arrival is **only possible** Monday May 25th 15h00 – 20h30 or Tuesday May 26th 08h00 – 13h00. Outside these times there will be no veterinarian on site to do the examination on arrival, and without that it is not allowed by the FEI to enter your boxes.

❖ **Examination on Arrival**

Follow the instructions of the parking guides. Go to the stable managers office and he will tell you which stables you have. Designated stables can not be changed. Go with your **horse passport and thermometer** to the veterinarian and have your horses checked.

❖ **Parking**

If you park your truck / horsebox / trailer on the showground you have to pay a parking fee, according to the FEI schedule, even if you take it with you in the evening to go to your accommodation. If you don't want to pay the fee you can park at the other side of the road on the field, but NOT on the showground. On this field will be no electricity.

❖ **Show office**

Show office will be open Tuesday May 26th 10h00. There you get your horsenumbers, accreditations and if needed Parking and Electricity ticket(s).

❖ **No shows**

Since the stables are built no shows will be on the riders account as from Wednesday May 20th on. Costs according to the FEI schedule.

❖ **Horse substitutions**

Please be aware that horse changes only can be done (by your Federation) till the last date for substitutions, May 26th 08h00.

❖ **Qualifications**

Please carefully read the schedules for qualifications for the Grand Prix, as for the moment we have more than 100 CSIOJ-riders.

❖ **Entries / Declarations**

Entries have to be done every day **before 19h00**. Please fill in the form you can open through the link code below so we can send you the link for the entries. We will send you the link for declarations Tuesday May 26th. You can use the same link the whole week.

❖ **Health Papers**

Please take notice: coming from another country than The Netherlands, except for Belgium, you need health papers. State veterinarians can be on site to check this. If you need new Health Papers to travel home or to another show, scan the QR code at the stable office or show office and fill in the form immediately **Wednesday May 27th 16h00** the latest. If you are too late new Papers cannot be guaranteed. We advise you to let make 30 days paper, so you can travel home on the same papers.
